

COWAY RUN 2020: BOSS FIGHT ROUND WK 1, WK 2, WK 3 and FINAL Terms & Conditions

1. Coway Run 2020 ‘Boss Fight Round’ Contest (“the Contest”) is organised by Coway (Malaysia) Sdn. Bhd. (formerly known as Woongjin Coway (Malaysia) Sdn. Bhd. (“the Organiser” or “Coway”).

2. The Contest runs on every Sunday in November 2020, from 7:00AM to 11:00AM. The contest dates are as follows:
